SHIPS DUES & DOCK RENT

Vessels become liable for dues upon arrival at the Port. This includes 7 days free of rent on landing and declaring fish through an agent. If no wharfage is paid on fish/shells landing, Dock Dues are chargeable on date of arrival to the Port of Fleetwood.

Dock Rent is payable in addition to ships dues and dock dues. Any vessel occupying the berth/quay wall that exceeds the 7 days will be subject to Dock Rent charge, per week or part of a week thereafter.

Offshore Windfarm support/service Vessels	
Small vessels (up to 30 metres LOA) engaged in activities associated with Offshore Windfarms, will be charged at a rate per vessel per week or part thereof. This weekly charge will cover all movements into and out of the Harbour or Dock for each relevant week and applies to vessels using the enclosed docks (commercial quay walls) and channel moorings with the Harbour Limits.	£854.11

GOOD DUES - WHARFAGE

Dues listed below are only charged on such goods as may be actually landed upon or pass over the quays or jetties out of the vessels berthed in the Docks or at the jetties or that may pass over the quays for shipment on board vessels lying in said docks or jetties.

LOCKING FEE	
Vessels entering or departing from the docks which are locked inwards or outwards within normal tidal period. Where overtime payment is necessitated, there will be an additional charge	£123.68 per vessel

***Please note that a metering system will be in place from 2024. All requests for fresh water need to be made 24hrs in advance.**

LIFTING EQUIPMENT

The customer must not bring any non-ABP cranes and heavy mobile equipment onto the Port unless the prior written consent of ABP has been obtained. In the event that ABP grants such consent, the customer shall comply with any conditions of that consent. Providing ABP in advance with a Risk Assessment Method Statement, a lift plan and a corresponding insurance policy to ABP's reasonable satisfaction.

The Customer shall be responsible for ensuring that: (i) the hardstanding areas of the Port are not loaded in excess of their load bearing capacity; (ii) any Plant it uses in its operations at the Port is not loaded in excess of its maximum load capacity as specified by the manufacturer of such Plant.
